## **Welcome to Oak Grove Park, Naval Air Station Pensacola!**

To use the park you must be active duty military/dependent, retired/dependent, DoW Civilian, Veteran with VHIC or authorized by the Commanding Officer of NAS Pensacola. You and your guests are subject to DoW regulations and station policies while onboard NASP. Any violation of station/park rules will result in eviction.

### **PARK RULES AND REGULATIONS**

*Please report all problems during business hours to the Office at 850-607-5032.  
After hour, contact the camp hosts at 850-572-4863.  
For any emergency dial 911.*

- All bike riders and skateboarders must wear approved helmets.
- No riding in pick-up truck beds, on sides or tailgates.
- All motorcycle riders must conform to DoW traffic regulations. Proper PPE (helmets, gloves, long sleeve shirts, long sleeve pants) is mandatory.
- Speed limit is 5 MPH in camping/cottage area.
- Cell phone use is prohibited while driving in the park.
- **ALL** Privately Owned Vehicles (POVs) must stay on authorized roads and parking areas. Off-road driving is prohibited.
- Must be a licensed driver to operate any POV. Occupants of POVs must be seated at **ALL** times.
- No ATV/UTV or dirt bike use on Federal property.
- Only street legal (registration, lights, horn, mirrors etc.) personal golf-carts with valid handicap sticker are permitted.
- Drone use prohibited.

### **RV Park and Cottages**

**Check-In: 1500**

**Check-Out: No later than 1100**

### **Quiet Hours Strictly Enforced from 2200-0700 daily**

**CAMPING:** Campgrounds will be kept clean at all times. Trash must be placed in provided dumpsters.

- Cutting of trees is prohibited. Do not break tree branches or damage park shrubbery for fire fuel.
- No metal detectors are allowed.
- Do not feed wildlife; feeding feral wildlife is strictly prohibited.
- Do not dump gray/black water anywhere but in the dump station.
- Clotheslines may be used for towels and swimsuits only. Lines must be taken down at dusk for safety reasons.
- There are no pay phones; however, park offices have business phones for emergencies. The camp hosts also serve as a contact to report emergency problems after business hours.
- Tent camping is not permitted in or around the RV sites
- No open fires are permitted in or around the RV site; this includes tiki torches, portable fire pits etc.

**REGISTRATION:** Registration is required prior to occupying any RV or cottage. You may register at the Park Office from 8am – 4pm Monday thru Friday, or after hours and weekends with the camp hosts located in RV sites 10 and 52. You must show proper identification. Guests must be accompanied by their sponsor at time of check-in.

All vehicles, trailers, watercraft or RVs must comply with NASP instructions on vehicle registration/insurance and State of Florida requirements for the entire duration of the present reservation.

**LENGTH OF STAY:** No individual person, family unit, or individual RV shall be permitted to remain in the RV Park and Campground for more than 90 days, and subsequently must vacate all NASP RV Parks (Oak Grove and Blue Angel Park to include both Anchor Cove and Battleship Row) for a period of 60 days unless an extension is approved. There are 45 long stay sites (#1-45). Patrons can stay 90 days in long stay sites. Sites #46-51 are designated short stay and must be vacated after 14 days.

No permanent residents shall be permitted in the RV Park or Campground. An individual may not register his or her permanent address using the RV Park or Campground on any legal documents, including state licenses, and military personnel or dependency records.

**VISITORS:** For your safety and security, please register all guests with the Office. Sponsors are responsible for the actions of their guests at all times. Authorized patrons may sponsor one guest (one RV or cottage) for a maximum of 14 days, at which time the guest must vacate the park for a minimum of 30 days. Sponsors must be present at time of registration.

**RV REQUIREMENTS:** Only RVs from recognized RV manufacturers are allowed. No aftermarket campers permitted.

**PETS:** Pets are allowed; however, they **MUST** be kept on a leash no longer than six feet and under immediate control of owners. Pets will not be left outside unattended. They must be walked outside of the camping area and droppings must be picked up and disposed of. Failure to do so will result in **revocation of pet privileges** while staying in the park. Animals are **NOT** allowed on beaches or in the swimming areas. Patrons with extremely noisy or vicious pets will be asked to leave. Having pets at the park is a privilege; please be mindful of others. **Pet pens are allowed but they cannot exceed 10-ft. by 10-ft. (100 square feet).** Pets cannot be left unattended at any time. Pens must be removed or placed on concrete pads during mowing or weed eating. Pen area must be kept clean and odor free. **Sorry, pets are not allowed in the rental cottages or surrounding areas.**

**BATHHOUSE & LAUNDRY FACILITY:** Only registered guests may use the facilities. The bathhouses and laundry are available 24 hours a day, with the exception of daily cleaning. Children must be under parental supervision at all times.

**PARKING:** No more than two vehicles are allowed per RV site or cottage. Boats & trailers are **NOT** permitted to park at any campsite. Tow dollies may be stored out of site at the back of RV pads. Vehicles may not block any roadway, other campsites or access to any park facilities. All vehicles parked in the campground or mobile home area must have a current registration card displayed on the dash or attached to show ownership and departure date. Registered guests may park their boats and trailers at no additional cost in designated overflow areas. Each trailer must display a current Oak Grove parking sticker. The sticker must have the space number and date of departure clearly visible. Trailers with no sticker or expired sticker will be removed at the owner's expense. Boat/trailer registration must be current.

**WASHING OF POVs/EQUIPMENT:** Washing of vehicles/equipment within the park is prohibited. **NO CHEMICALS OR BIODEGRADABLE ITEMS OF ANY TYPE CAN BE USED IN THE PARK OR ALLOWED ON THE GROUND.** Very limited mechanical/repair work (check and fill fluid levels, air up tires only) can be performed in the park. Please check with the office for assistance or directions to the MWR Auto Skills Center on Corry Station.

**FIREARMS/FIREWORKS:** No firearms or fireworks of any kind are permitted on a Federal installation.

**BEACHES:** There are no lifeguards on duty. Swim at your own risk. **PLEASE, NO GLASS CONTAINERS ON BEACH.**

**EXTERNAL ELECTIRCAL EQUIPMENT:** Only electrical equipment supplied by the RV/trailer/camper manufacturer may be used. Prohibited items include electric air-conditioners, heaters, hot-tub heaters, washers, dryers, refrigerators, microwaves etc. This list is not all-inclusive. Small portable electric equipment such as leaf blowers, fans, or radios may be used for short durations. If in doubt ask permission before using any external electrical equipment.
