1. Access will be allowed to Corry Sports Complex at 10 am, **Sunday, MARCH 12, 2017. DUE TO TRAFFIC SAFETY CONCERNS, NO VENDOR VEHICLES ARE ALLOWED IN OR ON SALES LOT ROADWAY AFTER 11:30AM. Plan accordingly**
2. Sorry, no refunds. All site sales final. In the event of **severe** weather, the rain date is March 19, 2017.
3. Food & beverage sales by vendors are prohibited due to health requirements.
4. No pets allowed. No live animal sales.
5. All participants are responsible for their individual change fund.
6. Spaces may be booked by military, retired military, DOD personnel and the general public.
7. Vendors may bring canopies, but no tent stakes may be put into asphalt.
8. Vendors may park two vehicles on the grass behind your paid area.
9. Vendors must keep merchandise within their paid area.
10. MWR can not be responsible for any articles lost or stolen. Each area must be manned at all times by the renter of the space.
11. Children must be supervised at all times.
12. Make checks payable to MWR Fund. Credit card accepted.
13. Corry Youth Sports Complex (sale site) must **be vacated NLT 5:30pm Sunday.**
14. **Vendors must clean up and remove all trash and unwanted items from sales site.**
15. **A cardboard recycle container will be available for your convenience.**
